STATEMENT OF UNDERSTANDING

1. All participants must listen to safety briefings and instructions before taking part in the activity.
2. All participants should obey the instructions given by SALTWORKS SUP staff & instructors.
3. Strictly no alcohol (if you are not fit to drive a car you are not fit to go out on the water) or recreational drugs to be consumed before or during the activity. If you have consumed prescription medication prior to the session, please advise your instructor.
4. All protective clothing, including PFD's/leashes must be worn for the duration of the activity, where applicable.

5. All equipment must remain on site & returned to the designated area after use. The equipment remains the property of SALTWORKS SUP and in the event of any damage being caused to the equipment through fault of the user, the participant is liable to pay for the repair/replacement.
6. All participants must understand that water-sports of any nature can be a dangerous activity. Whilst we make all attempts to safeguard our customers from such dangers, accidents & injuries can happen.
7. I understand that each SUP session may require me (or my child) to take part in moderate exercise for several hours. I believe that I (or he/she) is capable of this taking any factors mentioned above into consideration.

STATEMENT ON ADVENTURE AND RISK

I accept that adventure sports such as Stand up Paddleboarding contain an element of risk that SALTWORKS SUP cannot eliminate without undermining the adventurous experience.
